

Some Strange Things About This Epidemic

We are living through a fearful pandemic, and lockdowns and vaccine programmes which are helping to control it. At least that is what we believe.

But there is some strange news bubbling under the normal news which doesn't seem to fit. This suggests there may be questions to be asked about the pandemic.

Can it be that what we see on TV and read in the papers is not real?

If the information in this leaflet is right, and the pandemic is exaggerated, how is it that we see so much evidence of the pandemic, and the overwhelmed NHS. This is the big question.

The first answer is that undoubtedly the NHS has been overwhelmed in some places at some times. And many people have died or become seriously ill because of Covid-19. I would not want to disrespect exhausted NHS workers or bereaved families or sick people by questioning that.

It is question of scale. How often and how much has the NHS been overwhelmed? It is easy to show alarming scenes and write frightening articles without finding out how widespread the alarming scenes really are. In the atmosphere of panic, the media home in on the images the public want to see. This, together with the points I make in this leaflet, could explain how the pandemic in the media may be worse than the pandemic on the ground. But I would not want to suggest there is no pandemic at all. To my mind that would be woefully unrealistic.

The first strange thing about this epidemic is that it started in Wuhan in China. We are told it started in the animal market there. Other cities have those markets but Wuhan has a virology research centre. This lab was working on the coronavirus, on "gain of function" research, which makes the virus more powerful. And several good sources say that this coronavirus is not naturally occurring and must have been created in a laboratory. Analysis of

its genome reveals that. This suggests that the epidemic was caused by research on vaccinations. And it is now becoming known that the US helped fund that research.

The second strange thing is that there are other safe, effective and cheap conventional medicines which can treat covid-19. One that is in the alternative news is Ivermectin, which reduces the rate of serious illness and death to a fraction of normal, but its use is forbidden. Some doctors have been pleading to be allowed to use it but have been refused.

There is a similar story with hydroxychloroquine. An article appeared in The Lancet in the spring of 2020 saying that hydroxychloroquine should not be used to treat covid-19. The research showed that it was toxic. But the article subsequently had to be withdrawn and it was discovered that absurd doses, far larger than normal, were used. However the damage was done and with the help of other measures, hydroxychloroquine is effectively banned in many countries. It is a well known safe and cheap drug and it works very well for covid-19. Indeed it is said that some of the countries which are coping surprisingly well with the virus are doing so because of hydroxychloroquine and Ivermectin. How strange it is that medicines which can make covid-19 curable and stop it being something to fear have been taken off the market.

The third strange thing is that the test used all over the world for this virus is the PCR test. This test was never intended to be used to diagnose covid-19 or any other illness. It multiplies any traces of any virus, even the old coronaviruses that cause colds, and gives as many as 90% false positives. This means that the number of infections being reported is inflated upto ten times. So the epidemic is made up of a small number of real covid cases and a large number of false positives. These false positives are not really infected. On top of this most of the people who are actually infected are not ill and cannot spread the virus. There is a double exaggeration going on here. Is it not strange that such an unsuitable and misleading test, and such distorted figures, should be used to decide the government policy on lockdowns?

The fourth strange thing

News reports give the number of “cases” of covid-19 as if these people are actually ill. Most are not, they are merely people who test positive using an unreliable test. The media seem to be giving us inflated statistics. In the midst of pandemic panic, journalists are not questioning the figures they are being given.

This is partly by choice and partly by compulsion—journalists have lost their jobs for asking these questions. And some new regulations are not helping. It is against Ofcom rules for the BBC to say anything which goes against government policy

The fifth strange thing

The fifth strange thing is the way deaths from covid are counted. Any deaths within 28 days of a positive PCR test, from ANY cause are recorded as covid deaths — so the figures are bound to be much higher than they should be. Also, the more tests are done the more the death rate will go up, automatically. Doing more tests can make the epidemic appear worse. How strange is that?

And what of figures for hospitalisations of covid cases? They will be inflated in the same way.

The sixth strange thing

In India case numbers and deaths were very low. Ivermectin was being used. The figures changed in January 2021 when vaccinations began. Could it be that the epidemic in India is caused by vaccinations? Some stories from India support this theory.

In the UK the MHRA has received reports of about 300,000 adverse reactions to the vaccines unto 23 June 2021. Adverse reactions are underreported. Could something similar be happening here?

The seventh strange thing

Geert Vanden Bossche is a leading virologist who is pro-vaccines, but he is recommending that this global vaccination programme must be stopped immediately. He says that partially effective

vaccines are making the virus evolve and become more dangerous. Nobel prize winner Luc Montagnier and Doctor Robert Malone, who was involved in creating the Moderna vaccine, agree with him. Could it be that it is not the unvaccinated who are driving the variants but the vaccinated? If there are more lockdowns, could they be because of the vaccinations?

Lockdowns and Vaccinations

To summarise: Covid-19 has very effective treatments which have been made unavailable. And the epidemic was possibly started by vaccine research. We are not getting a true picture of what is happening. All these strange things are not being reported in the media and are being censored online by so-called fact-checkers. So we are not asking the questions which need to be asked. Maybe Covid-19 is not as bad as we think and can be managed in less devastating ways. It seems that the lockdowns and vaccination programmes could be based on an exaggeration of a real epidemic, and could be causing more harm than the virus itself.

Censorship

The Daily Telegraph is more sceptical of government announcements concerning Covid-19 than The Guardian. The Guardian receives funding from the Bill and Melinda Gates Foundation. The Gates Foundation also funds many other media outlets globally, and therefore has a big influence on the news worldwide. It is also one of the largest funders of the World Health Organisation, and exerts undue influence over its policies, even though it is not in any way a government or public body. And Bill Gates is probably the world's biggest vaccine investor. This suggests that Bill Gates could be controlling global health policy and media coverage of the pandemic to generate massive sales for vaccines, and massive profits for himself. With his Microsoft wealth he could be corrupting the WHO and influencing us and our governments for his own benefit. He also funds the UK Medicines and Healthcare Products Regulatory Agency.

News which doesn't fit the mainstream narrative is being censored. So it not possible to get a good impression of what is happening

from the mainstream media. Under the guise of promoting vaccination uptake to control the pandemic, sensible sources which question the mainstream narrative, such as Childrens' Health Defence website, are being blocked. We should be very concerned about this erosion of freedom of speech.
