## Research on Health Outcomes for Vaccinated vs Unvaccinated Children II: An Interview with Dr Brian Hooker Ph.D.

**Dr Brian Hooker** [**BH**]: I really appreciate the opportunity to share my research with you.... The way that the [US] vaccine schedule is being administered now is a gross injustice.

**Jonathan Otto** [**JO**]: Let's go into credentials here, for the camera, before your presentation.

BH: Sure. I received my Ph.D. in chemical engineering in 1990, and I've worked in the biotech industry ever since. I've done a variety of research – a lot of research on molecular biology, so I understand the ins and outs of the genetics, which has been really helpful to understand some of these MRNA vaccines and DNA vaccines that have been introduced for Covid-19. I've also for the past 10 years focused on the epidemiology of vaccine injury. I became very very interested in this, and starting in the early 2000s I have published about 15 papers on the epidemiology of vaccine injury since that time, and have also investigated specifically the CDC in the United States (the Center for Diseases Control and Prevention), and started investigating them in the early 2000s because I felt like they were lying to the public; they were committing fraud and malfeasance; and then subsequently, a whistle-blower came forward in 2014 – Dr William Thompson – and that then led to the revelation that the CDC was covering up the fact that the MMR vaccine could cause autism. And then that led to the movie 'Vaxxed' – and so things have really exploded for me, especially after the past six or seven years.

**JO**: ...I can only imagine, as a father, the driving force behind what happened to your own [vaccine-injured] son, and your desire to see justice served; that if the story could be told, if the truth could be known, that it would somehow make everything make sense, and that there were reasons, there was something behind this purpose.... – that somehow these truths would come to fruition, that you'd be able to not just let things happen to you, but *for* you; and I think that that's the power that this community has,

and people don't realise the fortitude and longevity of people such as yourself... because they don't have that depth of soul that it takes to do this work, to fight this fight – the meaning that's behind this and the divine purpose that's here.

**BH**: Absolutely – and I can attest to that.... A lot of the people in the health freedom movement have vaccine-injured children – you can give your ashes to the Lord and he will give beauty back. In my son's life, some of the things that have been spoken over him are now prophetically coming to fruition, and we're seeing him blossom into this young man, which is, just, so so eloquent. And so we're heartened by that. And we have to continue to warn others, especially in the Covid-19 era.

I am very very concerned about the different variants of the Covid vaccine, and just the amount of injury, the sheer carnage that these vaccines are causing in real time. So it's incumbent that we warn people about this....

**JO**: ... Now can you run me through [your research]?

**BH**: Yes, this is part of a presentation I gave at a recent conference in Chicago.... This is a compilation of not only the current state of vaccine science in the Covid era, but also two research papers that I completed with Neil [Miller], where we looked at the effect of the whole vaccination schedule on a cohort of children, and we compared them to children who are completely unvaccinated.

[Showing power point slides] We are surrounded by sick children, and sickness in childhood is now normal. Some 54 per cent of children in 2011 were diagnosed with some kind of chronic disorder – that includes obesity; and that number has increased since that particular time, and that is up from the 1980s. In fact in 1989, the number of children in the United States with chronic illnesses was 12 per cent, so that's gone up by more than *four times*. Neurodevelopmental disorders are diagnosed at the rate of 1 in 6 in children in the United States. And autism spectrum disorder... – 1 in 54 is now an old number – it's now about 1 in 40. And if you look at males, it's more like 1 in 20.

And then there's been an explosion... – what happened starting in 1989 that caused this explosion in chronic illnesses in children? Essentially what happened was the expansion of the vaccination schedule. In 1986, Congress passed the National Childhood Vaccine Injury Act, and when they passed that Act, that gave liability protection to vaccine manufacturers, and they started to add vaccinations to the schedule, liability-free.

Next slide: and so now the new frontier, the new market, is planet-wide vaccination, so that adults... – *Healthy People 2020*, that was an initiative pushed by the CDC and also the World Health Organization, looked at pushing the adult vaccination schedule....

**JO**: Did they talk about mandatory vaccines for adults, or not?

**BH**: Well they *were* looking at mandating vaccines; Johns Hopkins University – the School of Public Health and the School of Health Security – actually were

recommending tying vaccination to employment status, to different types of benefits you could get from the government....

**JO**: That's like a covert way to say 'mandatory', right?

**BH**: Yes, that is a very polite way to say 'mandatory vaccinations'. Oh, you can opt out of the vaccines, but you won't get any money and you'll probably starve to death because we're going to withhold all of your benefits or salary, and freeze your bank accounts...

**JO**: That *Healthy People 2020* – what year did that come up in? – that proposal.

**BH**: I don't know exactly... – I think it was in the early 2010s when they started to work on *Healthy People 2020*....

**JO**: ...because I know we've talked about 'the truth about vaccines', and that was about six years ago. So we were talking about that [then], and we mentioned mandatory adult vaccinations in that [discussion]; so is it a coincidence that we had Covid break out in the year 2020, and the vaccine roll-out – was this part of a plan? Had this been mapped out not just years before but potentially a decade before?

**BH**: Well it seems like the powers-that-be, and people like Tony Fauci and Bill Gates, were prophetic, because they were predicting the pandemic of coronavirus, and actually nailed it in September of 2019, and that's when the first escape happened from the Wuhan lab; that's when the individuals in the Wuhan Institute of Virology and China became sick. So I don't think there's really any coincidence there. Fear sells, and the individuals behind the vaccine mandates, and the individuals behind the Pharmaceutical Industrial Complex, knew that the only way they could get individuals to comply to the adult vaccination schedule is if they could hold them in a serious suspenseful level of fear.

And so I don't think it's an accident. I fear what is coming up next, because individuals like Bill Gates are saying that we have to prepare, and there'll be a new pandemic. And it seems like they've queued up hemorrhagic fever or Marburg virus in the wings to be the next pandemic, in order to continue to scare the populace into vaccinating.

**JO**: Wow! That's really telling....

**BH**: Marburg is a type of hemorrhagic fever that's similar to things like Ebola....

**JO**: Yep..... Some people fear that that could be Covid vaccine injuries being packaged as another disease....

**BH**: You know, it's very very difficult to say. There are lots of things that contaminate these particular vaccines; and we're seeing, like the next slide says, the CDC's adverse events reporting system – this is the United States' main surveillance system [VAERS] – it's blowing up, with 97 per cent of all injuries that were reported in 2021 being due to the Covid-19 vaccine; and over one million vaccine injuries now that have been tabulated and reported, and many many more waiting in the wings –

specifically from Covid-19 vaccines. And over 24,000 deaths. And we know that VAERS is under-ascertained: that level is probably 30 or 40 times lower than the actual number of injuries and deaths from the Covid-19 vaccine. So this is like nothing we've ever seen....

**JO**: And just quickly – where do you get the 30 to 40 times lower....?

BH: I can share the research paper. There was a research paper done by Jessica Rose – she's a scientist who's currently out of Israel, who looked at the actual rates of vaccine injury from clinical data from the Pfizer vaccine, and then compared it with the rates on VAERS. And she came up with this multiplication factor, which we call an 'under-reporting factor'. She came up with 30; and an individual blogger and a billionaire who's really been concerned about the Covid-19 vaccine, Steven Kirsch, did a similar calculation, and he came up with an under-reporting factor of 40. So somewhere in between that is the actual information, and we know that this has been under-reported because hospitals, medical providers, are refusing to report vaccine injuries to the CDC....
