We begin by documenting evidence proving that Covid was a 'plan-demic', before journeying on to confirm that news services are routinely bought, bribed and sold. Hereby we lay bare two cornerstones of our current delusional take on reality, a commercially orchestrated pandemic and heavily propagandised news service! Sadly, as government is implicated in all this, we can't complain to our Member of Parliament.

In our previous essay in this series (Barber & Barber, 2021) we explored in some depth the effects of vaccine-induced spike proteins, and warned about the prospect of auto-immune reactions (ibid.). Since then, our speculation has emerged as a real live threat, so in the present article, we plunge more deeply into the prospect of vaccination-induced AIDS. And as for 'war'; what better word sums up the blind obedience, brutish bio-fascism and wanton irresponsible destruction of people and livelihoods we are currently experiencing?

A wonderful thing is man, with potential to fly with the Gods or graze with the herd. Are you, dear readers, right now inadvertently courting wings, or udders?

(Part 1) Act 1: Conspiratorial Ripples with Ever More Lies

We are in the middle of a big swamp of ignorance that is taught by a lot of nonsense, propaganda, absurdity, amalgams. I have a hard time listening to any speech. You feel like you want to stop the TV every two seconds to rephrase them, because it's lie after lie, turning stuff upside down, and you can't follow that. That's the trap.

Sometimes, the most profound and intriguing information comes from the least likely source – accountants! A case in point concerns the under-writing of patents. Who would have thought that a non-player like 'the patents office' would have come forward from the wings to centre stage to become a star?

Applications for new vaccines go through the patenting office, which keeps copious records dutifully stamped with times and dates. This area has recently revealed surprises. In a recent article, we suggested that if you want to understand what keeps the Covid show on the road 'just follow the money' (Barber & Barber, 2021). How right we innocents inadvertently were.

Our supposedly newly invented 'rushed through' gene sequenced vaccination, we learn now, is no spring chicken, but some 22 years old – as proven by the official patent record. Indeed, if we accept that there are idiopathic pneumonias, nothing has essentially changed on the wider virological front since SARS in 2008 (DSA, 2021). Spike protein, the hidden killer in Covid vaccinations, likewise, we will discover has an impressive 'man-made' history.

How come all this is springing into light now? Dr David Martin, a professional seeker after truth, used his firm M-CAM geared to locating Intellectual copyrights to investigate over 4,000 patents relating to SARS Corona virus – with a particular focus on financing. Thank God, yet again, for accountants! They took the genetic sequences of Covid vaccine 'reported as new', reviewed these against patent records, and found that as of Spring 2020, over 120 failed so-called 'new patents' from as early as 1999. Our 'newly' invented spike protein was also found to have an impressive family history extending back 21 years! Old enough by now to have come of age. Someone has been telling us a mis-truth, and we don't think it's the patent record!

It is sobering to note that prior to 1999, our good old Covid shot was a veterinary vaccine for animals, and Pfizer was busy identifying *canine* spike protein candidates (ibid.). Today, 'we' have replaced the experimental dogs! Woof bloody Woof! Such is progress?...

Dr Martin – who to our mind is rapidly being sanctified as the patron saint of accountants – suggests that spike proteins were introduced to increase demand for future vaccines (DSA, 2021), a charge that has recently gained backing as mRNA vaccination knocks out natural immunity, leaving little to replace it with other than more injections (Aasish, 2021). Though spike proteins are already known to effect cardio-vascular accidents, they have been discovered of late to house an even nastier surprise: they appear to severely cripple DNA regeneration – up to 90 per cent, which in turn stimulates cancers, auto-immunity plus accelerated aging. This may start as soon as we expose ourselves to sunlight and our bodies discover they can't undertake DNA repair (Jiang & Mei, 2021). Has Pfizer then laid a time-bomb within us? This latter hypothesis will be explored in depth later.

Why was it so easy for Dr Martin and co. to track this deadly game of vaccine roll-out? Because they'd seen 'Big Pharma' *attempt to do it all before, in an anthrax outbreak in 2019:*

So for us it was not hard to figure out it was not a public health crisis but an opportunistic marketing campaign to address a stated objective – they needed to get the public to accept a pandemic virus to accept a vaccine counter measure with media creating the hype where investors would follow and see profit. (DSA, 2021)

Discomforting words, but not half as chilling as the national death rate which, statistics reveal, continues to run at an uncomfortable high in the USA and UK since the introduction of vaccines (Berenson, 2021). We know this for certain because the ‘Official Office for National Statistics data has inadvertently revealed that 30,305 people have died within twenty-one days of having a Covid-19 vaccine in England during the first 6 months of 2021’ (Turner, 2021). We have pandemic deaths right enough, but from vaccination, not Covid! Put simply, vaccinations are unsafe – period. Yet make formal inquiries for the statistical data shared here, and the official response is ‘we do not hold the information required’ (ibid.)! Nanny State has always known what’s best for us, and we, under the opiate of imagined freedom and/or apathy, were largely content not to rock the boat. So why should it change now? Have we not got what we wanted and deserve – but in greater measure than expected?

The uncomfortable question must be asked: ‘Why do governments go along with vaccination and conspire to hide the truth?’ Why do they perpetuate the *hype*?

Pfizer is well reputed to grease the palms of key players to promote its interests (Violation Tracker, 2021), but this aside, why would government focus so much attention and capital upon Covid when the vast majority of cases, similar to flu, fall under the 80/20 rule, where 80 per cent are mild, and 20 per cent more severe? In more severe cases, this is all too often because recipients suffer pre-morbid conditions – so where’s the crisis? Obviously, the attention lavished doesn’t stack-up, and only adds fuel to speculation that Covid was introduced to alleviate problems of over-population, and initiate systems of social control that nation states have been wrestling with for years. Nothing here, then, to quell the fear growing in many quarters, of ‘genocide by vaccination’ (Peters, 2021). Sadly, in light of evidence from the patent record, it is also impossible to refute this charge, especially as Covid, vaccinations and spike proteins are all derivations of germ warfare and, as a final nail in the coffin – Moderna began planning the sequencing of a vaccine a month before an outbreak ever happened! (ibid.).

The mystery now deepens as a shadow of paranoia comes alongside us as an everyday companion on our journey through this unfolding play.

Having surveyed the evidence of this opening prologue, in a biblical sense, do you believe John the Baptist – the lone voice crying in the wilderness of Dr Martin, or the Pharisees – the group-speak of the prevailing high priest order (Government Health Advisers)? The prophet, or the establishment? Granted, we present a very biased sample here representative of the counter-culture we support, but surely you’ve had more than enough mis-information on TV, in the news, via governmental and medical directives to counter-balance our very own home-grown user-friendly propaganda? If you don’t chase up the references of this paper, it all boils down to belief, and where you choose to allocate truth. Whether you are in danger of believing ‘us’, or prefer to remain believing ‘them’.

We are not hard-hearted folk. We do commiserate. After all, what a bother it is to chase the references behind our statements: it’s far more comforting, in the short-term, just to believe ‘them’ and give ‘them’ what they want and to hope they’ll go away. But in the long term...?

Act 2: A Plan-demic beyond Reasonable Doubt?

Cynically we ask, before this play continues in its current documentary mode, how have we dumbed down or allowed ourselves to be brainwashed into globally accepting a ‘new’ vaccine that had been around in pharmaceutical quarters since 2004? How and where did this drama within a drama all start?

It’s ever so hard to stop a dedicated man.

We know from official records that from 2016 to 2019 that good old Anthony Fauci, of pharmaceutical and WHO fame, was lamenting in various meetings that he couldn't find enough people to accept his universal influenza vaccine, his favourite target for mass vaccination prior to Covid. Interestingly, in March 2019 an amended patent filing of Moderna stated: 'what if there was a release of a pulmonary corona pathogen?'. This exact phrase seemingly had wings, for it flew into a WHO paper of March 2019 – even before there was an alleged pathogen! A miracle of prophecy, no less! This phrase also found next in a mandate of 'what must be completed by Sept 2020' by the Global Preparedness Monitoring Board – an independent group of global leaders 'helping make the world safer from a perspective of health emergencies'! Who further professed, prophetically: 'we need a collaborated global experience of respiratory pathogen release so that by Sept 2019, we can put into place a universal capacity for public relations management, crowd control and the acceptance of a universal vaccine mandate' (DSA, 2021); such foresight is stunningly accurate! Add to this Moderna's patent applications being amended in 2019 to include respiratory infection language, and someone appears to have a very efficient crystal-ball!

Obviously, many were working with a specified date in mind towards the launch of a world-wide pandemic.

The notion of a plan-demic hypothesis is further attested in the pre-pandemic language of Peter Daszak: 'We must create public hype to get the public to accept an international virus vaccine' (ibid.). When comments like this are openly minuted, we are dealing less with behind-the-scenes conspiracy than cold-blooded brazen cheek! One cannot but be impressed by such open mockery of us, the public. How very conditioned they perceived us to be to believe in the orthodox news services and so-called medical authorities; how dependent they thought we'd be on experts and those we were told knew best – wait on, we did! Shame on us.

An interesting character is Peter Daszak, who was previously involved with weaponising drugs, but who is now surprisingly employed by the US government as a Covid health advisor (Covid Revealed, 2021)! We will hear much more of Peter later, when this unfolding plot thickens. Regrettably, too, many of us believed, and still believe, 'hype'! So, there is obviously far more than 'only one born every minute'.

Was it a pandemic or not a pandemic? That is the question!

Let's go for the biggie, Corona virus itself. It was declared a dead interest and written off by the WHO in 2007, who claimed it irradiated as a concern. But if this were really so, why did the US government continue to spend millions of dollars upon a thing that was written off? It appears Corona was still seen as a highly malleable bio-weapon, so its research went underground (DSA, 2021). Indeed, records suggest that prior to 2005, Corona was deemed a bio-weapon of choice. Can't have too much of a good thing now, can we? So, let's share it with others!

Moving forward a little to our own sorry times, we cannot easily plead ignorance and say we were not forewarned about the unsuitability of a rushed-out untested vaccine or its untimely roll-out, for Dr Vanden Bosche, a world leading virologist warned us repeatedly that vaccinating people in the middle of an outbreak would accelerate a virus's ability to mutate and produce gain of function – meaning vaccine-resistant strains. Most lay virologists and even junior nurses know this, so did the whole world suffer a senior moment? For this farce still went ahead to produce surges of Beta, Gamma, Delta and now Omicron – but then again, are these real live variants, or merely a cover story for the accelerating wave of vaccine deaths (Brighton, 2021)? Last but not least, Bossche observed, if you train the immune system to fixate on one specific piece of the original SARS CoV-2 virus – the spike protein – you run the danger of it being *non-responsive* to future variants, or even common pathogens. In this context, he asks, what would be the future impact of a common cold or a flu endemic? (Elliot, 2021). Genocide by vaccination is now a very real possibility as this whole sorry farce turns swiftly towards tragedy. But whoever bothers to look, let alone read the writing on the wall even though writ large, when not upon the telly?

Is Covid merely a warm-up act for more devastating interventions to come? Are we being softened up for the kill? A micro-chipping of the human race or other attacks on free will? How zombified have the masses become already, that we, the unvaccinated, have begun to feel like the untouched ones in a zombie movie? How near to the living

dead have we en masse slid? – or have further yet to slide? Anything is possible – but likely? Would you have believed world lockdown three Christmases ago?

With government figures broadcasting an increase in Covid numbers, in spite of a higher percentage of the population being fully vaccinated, surely it is obvious that vaccines have failed to do any other than breed a bigger crisis than the one we began with:

After 111 million injections administered in 2021 in an attempt to protect a population from a virus that is 20 times less deadly than it was in 2020. Surely the above data can only be viewed as an unmitigated disaster. BECAUSE MORE PEOPLE ARE DYING. (Littlewood, 2021)

When we drive through Bucharest and see queues waiting outside hastily erected job centres, we recall how ghetto Jews in Nazi Germany sewed yellow stars on themselves and their children before selection for the death camps. Faced with authority, how compliant some people can become in their own and their children's destruction!

Put all the information together, and again we see more are dying from vaccination than Covid! And they keep pushing their lethal vaccinations – and we keep queuing up for more! Did you buy the hype around booster shots? Will we still fall prey to the next vaccination drive for Omicron, plus all and everything else that follows?

If you aren't yet convinced, take one more example, Israel – a most glaring example of failed mass vaccination. President Netanyahu, no doubt believing the best, sold out his country in an exclusive contract with Pfizer. But as Dr Peter Doshi (editor at the *British Medical Journal*) points out, 'waning immunity' can so easily reverse any immediate suspected gains from vaccination (Doshi, 2021). There was never a truer word. In early July 2021, the vaccine was 64 per cent effective, but by late July 2021 only 39 per cent effective! Clearly, effects didn't hold. How come we only discover this now? 'Pfizer supposedly doesn't have any data past six months into their trial – i.e. March 2021' (Elliot, 2021). At least none, as we find below, that they chose to share!

Ignorance is far from bliss, especially when it's conspired.

'Ignorance' of side-effects can never ever be a viable defence for Pfizer. For a recent document entitled 'Cumulative analysis of post-authorization adverse event reports' has come to light as part of a court-ordered release of 500 documents a month, ordered by an incorruptible judge who over-ruled the FDA's fight to withhold the same for 55 years – when of course most of us personally affected will be dead and gone and unable to sue! The document in question reveals that, just 90 days after the release of Pfizer's mRNA vaccine, they were already aware of 'voluntary adverse reaction reports' revealing 1,223 deaths and 42,000 complaints describing 158,893 side-effects. Aside from these so called 'general disorders' (note how death is subsumed here under 'general disorders'), the most frequently reported dysfunctions were nervous system ones – over 25,957 (Adams, 2021). Still Pfizer went full-steam ahead without further investigation. How many suicides due to severe depression have been classified 'Covid vaccination deaths', we wonder? – if any! Though Pfizer hides behind a pretence of public service, they are, have ever been, and threaten to always be, money-grabbing commercial sharks. Not at all the warm fluffy bunnies their product adverts and public face suggest.

Havoc and destruction as a natural and accepted part of 'business as usual'!

Though Pfizer has been largely successful at covering up deaths and side-effects, their sloppy, negligent drug trials and testing have received repeated critique from the *British Medical Journal* (Thacker, 2021). The pound signs in their eyes seemingly blinded them to the real issues – vaccine in-effectiveness and counter-indications. Not to mention how throwing 2nd and 3rd unreliable vaccinations into the pot, though making millions of pounds for themselves merely pumped more toxins into our communal blood, risking ever more variants, auto-immunity and further humanitarian damage. Was this the plan all along? Transcripts of telephone conversations between Moderna and vaccine research centres confirm that 'money', not 'public health,' was always their main driver. In fact, no real effort was recorded in any

pharmaceutical company conversation to correct a virus, the main objective on tape being to get people injected by a business-enhancing spike protein (DSA, 2021)! Then again, what do we expect of businessmen? Isn't Judas their patron saint?

Beware the vaccinated in our midst!

A further side-effect in emergence from the evidence of highly vaccinated countries is also worrying – namely, we appear to be turning the vaccinated into super Covid spreaders (Subbaraman, 2021). The Amish community who refused vaccination and developed naturally acquired herd immunity obviously got it right (Brasscheck TV, 2021a). 'But isn't natural immunity one of the casualties here? Mother Nature knows exactly what to do. But these days she is marginalized (by such as big pharma, doctors and medicine) as an incompetent, interfering old busybody' (after George Bernard Shaw, 1856–1950). Plainly, with the benefit of hindsight, we may say 'no vaccination' was a better way forward than 'vaccination'! Yet we are still being told by Pfizer, our heavily censored news service and somewhat fanatical politicians, that vaccinations are 95 per cent effective and safe. Propaganda also continues to lay contagion at the feet of the unvaccinated, rather than at the feet of the real culprits – the vaccinated. But we don't have to believe them, do we? Thankfully there are shafts of light from the most conservative of medical press, *The Lancet* no less, which has begun to flag-up unjust persecution of the unvaccinated (Kampf, 2021a).

What a great idea – let's kill two birds with one stone, and blame the un-vaccinated! Not any more.

In truth, the press can no longer with impunity blame the unvaccinated for the new variant waves washing over us, when in fact those vaccinated two or more times have much more to fear by re-infection from themselves. Leading virologist Dr Robert Malone, one of the inventors of mRNA technology (Nicolae, 2021) has personally confirmed that many more vaccinated than unvaccinated are now being infected, infecting others, and dying of Corona Virus – all because of 'immunity suppression'. Another Pfizer boss, Dr Albert Bourla, has recently confirmed that we will need vaccinations for life – because of 'immunity suppression'. *For life*, note! 'Immunity suppression through vaccination' is the open secret Big Pharma is desperately trying to hide! Robert Malone felt so strongly that he took to YouTube to make this very point, as he was denied a platform elsewhere (Malone, 2021)!

So, let's pause and become a little pedantic to let this one in. Covid vaccinations cause immunity suppression. Because of immunity suppression, vaccinated people are more prone to catching and spreading Covid, plus all other manner of diseases. Therefore, besides spreading variants to vaccinated and unvaccinated alike, vaccinations don't stop infection, but in fact actually cause more Covid infections! (Kampf, 2021b, p. 1). In terms of warped poetic justice, 'Only the Fully Vaccinated should fear the New "Worst Ever" Covid-19 Variant; data shows they already account for 4 in every 5 Covid Deaths'! (Exposé, 2021a, p. 2). The failure of masks, lockdowns, vaccines and their lethal nature can't be clearer than this, can it?

A conspiracy of silence exists everywhere, and so this simple and ever-so obvious message inclusive of 'immunity suppression' never gets out. But something is beginning to stir. US Food and Drugs (FDA) health bureaucrats, having once whole-heartedly backed vaccination, alert now to statistics that show the USA is ending up worse, following vaccination than before, having also been caught out as bed mates of Pfizer. They appear to sense a 'day of reckoning coming', and are jumping ship (Brasscheck TV, 2021b). The machinations of how 'Deep State' and Big Pharma took over such public bodies as the FDA – who, remember, were meant to protect us – are also convincingly narrated and confirmed by Dr Malone, who has seen the light and spoken thunderously against his own co-creation – mRNA vaccinations. When establishment sinners of this ilk convert to saints, we know the anti-

vaccination lobby is far from a lost cause. But how come it took him so very very long to see the light? And why now is he breaking ranks? Has his ship sprung a leak, too?

At grass roots, many more rats are fleeing sinking ships. For instance, a resigning Chief Nurse from a University Hospital Centre in Slovakia, who claims somewhat late in the day that she can no longer go on as before – that is to say, ‘doing as she was ordered’ – now sees fit to report that health workers such as herself were given three injectable substances for their patients: Number 1 – a saline placebo for a chosen powerful few always given by the same trusted person to dignitaries; Number 2 – a straightforward side-effect ridden mRNA vaccine; and Number 3 – an RNA stick linked to an adenoma virus contributing to soft tissue cancer within three years! (STOP: Leznivim Medigem, 2021). We tend towards believing this account – the more so, as the lady in question was prepared to be identified and interviewed on camera, and as 63 per cent of the country are practising Catholics, thus making pangs of conscience and confessions such as this understandable. We are also aware of several other reports from less verifiable sources on the internet that we have not quoted to date, for lack of evidence.

Morality, it appears, is an expendable commodity.

Lest you in the UK get too superior by believing that such inhumanity to man couldn’t happen there, be informed that the NHS drew up secret plans to withdraw hospital care from people in nursing homes in the event of a pandemic: ‘Confidential Whitehall documents show that the NHS plans refused treatment to those in their 70s and that “support” would instead be offered to use so-called “end of life pathways” (Telegraph, 2021). How come group-think so often degenerates to putting the weak against the wall? Just let the jargon sink in: ‘end of life pathways’ – far better said than murder, is it not? – though essentially the same thing. And who are the strongest in this dog-eat-dog scenario? But morally bankrupted power-holding un-elected dignities with a gentle smile upon their face hidden in committees and within behind-the-counter nursing ranks. The least worthy of our kind? Love them or loathe them, you have to admire the thickness of their skin – for no one with an iota of sensibility or moral fibre could contemplate such action. Gentle reader, would or could you sign off such a thing as this on your watch? Those answering ‘yes’ are invited to put this essay down and leave the room!

How many in senior positions, we ask, function as mere ‘jobsworths’? – officials who uphold petty rules at the expense of humanity and common sense. For ever fearing loss of their job and status, should they take a counter-cultural stand, they are all too easy prey to ‘Big Pharma’, which is rich and powerful and corrupt beyond measure – and pays well for infractions of the rules.

Institutionalised corruption and criminality have sadly all too often been forgiven.

Take again, for example, Pfizer – a major player whose public record shows that since 2000, they have paid over \$4,660,896,333 (four thousand six hundred and sixty billion, eight hundred and ninety six thousand, three hundred and thirty three dollars) in 71 criminal fines due to corrupt practices, inclusive of false claims; flaws in drug and medical safety; unapproved off-label promotion of medical products; missing research and healthcare records; improper government contracting and competition; plus environmental violation (Violation Tracker, 2021). How many of the above headings led to deaths, we wonder? And this surely is merely the tip of the iceberg – for how many grievances were settled out of court? And government still lets Pfizer practise – why ever why? Their record suggests systematic abuse and criminality without repentance or remorse, and what good, might we ask, are mere fines for a corporation where a million pounds is pocket money? What can we draw from this? That obscenely rich associations, Mafia-like, may pay their governmental dues and criminal fines and go on to plunder as before? – leaving us, the general public, as lambs for continued slaughter. Again, we are caused to wonder why governments stand idly by.

In '*Big Pharma*' money doesn't talk so much as shout! And Pfizer gets the best justice money can buy?

Given Pfizer's unsavoury record, we are tempted to go back to basics to ask, ‘Was there ever a real vaccine?’. Let alone variants? After all, we are actually being injected with a computer-generated ‘spiked’ simulation originally deemed ‘unfit for purpose’. Don't just take our word for it. When Anthony Fauci first tried to get his own synthetic injections passed, these were rejected as ‘unpersuasive to their use as a vaccine’ (DSA, 2021). What is more, the

patent office said his vaccine did not meet legal, nor patentable, nor even the health standards publicly required! But powerful bureaucrats know their way around the system, and loopholes were eventually found.

Thankfully, Fauci's days are numbered, as Robert F. Kennedy Jr has written a best-selling exposé (Kennedy, 2021), which involved a team of more than 20 world-class research scholars working for more than a year. Still, the fact remains that we have millions of people being injected with a pathogen-stimulating computer sequence sold under what the patent office and FDA's (the US Food and Drugs Administration) own clinical standards state is not a bone fide vaccine, but a sub-standard dangerous substance.

As we write this, Fauci is currently being grilled by the US Senate – a chink of light on the horizon?

So, what are we really doing? We're subjecting hundreds of millions of people to what was known by 2005 to be a biological weapon (DSA, 2021), that suppresses our immunity and makes us more prone to the very infection it was meant to eradicate! How many of those vaccinated would have dutifully queued up for vaccination if they'd known this?

Are there fearful variants or no fearful variants? That is the question.

Let's go the whole hog with this critique to place on record that Covid variants are likewise contentious. For instance, Delta has been identified by researchers as containing as many as 40,000 viral strains. With so many sequences at play, where you start and stop reading will produce what ever you focus upon. We can thus interpret a new sequence-cum-variant when essentially nothing has changed just by looking further along the continuum! Add to this that all the way through the patent filings and weaponisation patterns beginning in 2008, fragments were inserted without specificity, leaving gaps into which anything can be placed, so making true fact-checking impossible, for 'what remains is a manufactured illusion that cannot be assessed'. One could ask whether flu, colds and pneumonia have been subsumed in these virus type sequences? For no one looks for them any more, just Covid (ibid.)! 'Big Pharma' hereby creates a licence to print money, for they have a vehicle with which to diagnose Covid in non-Covid cases, or produce the delusion of a new variant with which to concoct ever-more-urgent vaccine demands! It's all very clever stuff that allows 'Big Pharma', with government consent, to toy with human lives indefinitely.

Must we continue to fall for all this criminal hype?

The commercial-cum-governmental partnership illuminated here veritably stinks of 'Deep State', where a hidden network of non-elected officials and bureaucrats, largely devoid of accountability – but with access to state surveillance, along with private entities weald together in shared purpose to form 'an informal government within a government'. How else can one explain the Centre for Disease Control (CDC), the national public health agency of the United States (one of whose many functions is selling vaccines), blatantly being allowed to warp statistical truth? 'Recently, doctors and hospital staff were directly instructed to mark every death caused by – in other words immediately following – a jab, as an unvaccinated person death' (Scott-Mumby, 2021). Here, we see the externalised influences of 'Deep State' antics illuminated around the recording of vaccine deaths and side-effects. To lay this deception out plainly, The US Centres for Disease Control and Prevention (CDC) don't count anybody as vaccinated within the first 14 days, until their second dose, so those who suffer death or side-effects within this period enter the records as 'un-vaccinated'. Neat deception, do you not agree? And how can CDC get away with this fraud without being an integral part of a much wider conspiracy? Obviously, it can't!

Is this a tiny example of how 'Deep State' keeps the pandemic going while covering their tracks? A bigger example being how they silence the press – our next theme in Act 4!

Before moving on, consider the 'Deep State-like' involvement of bureaucrats from FDA, who, we learn from newly released documents, were informed by Pfizer that their vaccines might well sicken and kill patients who were later infected with Covid; that they had no real information about their vaccine's effectiveness; and that it could cause

spontaneous abortions and kill unborn babies (Adams, 2021). Yet still, the FDA passed the vaccine and fraudulently pushed it as ‘safe and effective’, hereby making themselves complicit in the vaccine holocaust that resulted. If this is not enough to halt mRNA vaccines and to arrest FDA bureaucrats, what ever will be? The information is now out there, and *still* nothing is being done about it! Makes you wonder, doesn’t it? Especially as in 1974 Henry Kissinger recommended the need for depopulation, especially in under-developed countries in a governmental white paper (Moret, 2014)! So, we know the idea of population reduction is far from new, and has had ample time to mature within the inner arcane circles of government.

Thankfully, there is a new un-corruptible sheriff in town, and the above shadowy manipulations are at last coming to public attention (Kennedy, 2021). In his book, *The Real Anthony Fauci*, Kennedy describes how Fauci turned the National Institute of Health (NIH) – the USA’s premier medical research body – into an incubator for pharmaceutical products, essentially selling the entire country to the drug industry. He describes how Fauci conspired with Bill Gates to partner with the NIH in an agreement to vaccinate the entire population of the world with a battery of new vaccines. In 2009, this agreement was cynically re-branded as ‘The Decade of Vaccines’, with a stated objective of implementing mandatory vaccinations for every adult and child on the planet by the year 2020 (ibid.). Pretty successful, don’t you think? Didn’t they do well? When public institutions like the FDA are seduced or buy into a criminal cover-up in this way, our few remaining protectors in high places metamorphose into robber barons! It’s all so very greasy and unsavoury, like the individuals involved.

What more do we need to contemplate beyond reasonable doubt that an orchestrated and patent proven plan-demic has been released on the world? How about a video showing Fauci and HHS (US Health and Human Services) officials discussing the use of using a new virus released from China to enforce universal vaccines in 2019 (One America News, 2021)! Yes, honestly – October 2019! Please check-out this video via its web-link, then reappraise and modify any ‘conspiracy theorist’ label you might have hoisted our way.

The villains of our story are now writ large – Big Pharma, Fauci, the shadowy spectre of ‘Deep-State as evidenced by the antics of US public safeguarding bodies as HHS, CDC and the FDA’! We even have a hero emerging – Robert F. Kennedy Jnr.

If you need an intermission, this might be the time to take one! You’ve been bombarded with an over-thick feed of information that’s all so very hard to digest. A feast of lies from Big Pharma and government, the horror story of a vaccination derived from germ warfare being released on unsuspecting everyday folk, a commercial coup that’s destabilised human rights and law and order; and you’ve even faced the possible terror of government-sponsored euthanasia. And still the plot twists, and turns, and threatens to rip apart everything we value – our culture, common sense and decency, if indeed en masse, we haven’t passed a point of no return and lost the ability to recognise these in a communal sense already! But as my grandmother always used to say, ‘Where there’s life, there’s hope!’.

(Part 2) Act 4: Trust Not the News, Nor in all Manner of Mass Media

If you tell a big enough lie and tell it frequently enough, it will be believed.

Our earlier identified villain of ‘Deep State’, discussed in Part 1 of this article, can also be held accountable for news control – pre-fabricated, heavily censored information which an undiscerning public feed on, as if it’s their only window upon truth and reality. Look how easily the TV and press have hypnotised far too many gullible souls into believing in a dubious pandemic, and salvation by vaccination.

Mass media is the singular most important arm of State political control, and there is no such thing as a National Free Press. What a preposterous idea: surely you can’t be serious, old boy? Sadly, I am - and what’s more, I can prove it

A recently released volume, suppressed for three years and published posthumously titled *Journalists for Hire* (Ulfkotte, 2020), tells how perks are used to bribe writers and opinion makers to twist their reports. It illuminates first-hand how a tone of corruption is set from the top – ‘play along or quit’, plus to what degree the long arm of a NATO press office enrolls media to get Europe to support foreign wars. The author, himself a respected journalist, names outwardly respectable organisations as the Trilateral Commission and the German Marshall Fund as behind-the-scene players that influence German media with one-sided propaganda. He describes how government inspired under-cover agents write articles in editorial offices to be published later under the names of well-known journalists; pointing out which journalists receive bribes for their warped reporting; how prestigious ‘journalism prizes’ are a reward system for co-operation, and naming who has received them (ibid.)! We will discover below as in Germany, so the UK, if not in all countries.

When agents of state hold the hand that holds the pen, propaganda naturally results! God save us from those who ‘are only following orders’. Soldiers of the State!

Udo Ulfkotte died in January 2017, officially from heart failure – though subsequent research alleges murder (Schneider, 2020; Brennan, 2020). Whistle blowers of the ‘unofficial truth’ can sometimes pay a very high price.

The Press stinks just as much in ‘Dear Old Blighty’.

In the UK, a pincer movement by the Treasury and Ofcom, the UK’s communications regulator, has likewise gagged our once-proud news media. In 2020 the Government paid broadcasters more than £180 million to promulgate their COVID-19 messages to Britain’s public, with further millions to be dedicated in the future. Meanwhile, Ofcom determined that the broadcast media must stay in line with Government advice, with the threat of sanctions, should any media channel deviate from the official narrative (Hart, 2021). The consequences of this government-controlled censorship of mainstream media have been a stark and unprecedented brain-washing process worthy of the dark ages of the KGB!

Throughout 2020, as strategically recommended by SPI-B (SAGE’s subgroup of behavioural scientists), the British people have endured an unrelenting torrent of fear-inducing messages and images intended to lever compliance with COVID-19 restrictions. Towards a similar end, a macabre cumulative daily death count of those succumbing in the aftermath of a positive COVID test – reported out of context, with no reference to mortality from non-viral causes – has been a permanent fixture on our screens. Furthermore, science experts with views different from the dominant COVID narrative have been denied airtime, while mass protests against the restrictions, both here and abroad, have received scant media attention. (ibid.)

To use newspaper tabloid jargon – scandalous!

A government for the people without the people?

The UK government, while professing to be democratic, uses public money to bribe a publicly funded news media (the BBC) to fear-bombard the public with government-approved propaganda furthering its own agenda. In this way, cosy homely Auntie BBC drips red from tooth and claw, and a supposedly representative government employs fascist techniques to serve their interests. Say ‘goodbye’ to Great Britain, Land of the Free? Instead, welcome Lame Britain, Land of the Oppressed as a shining example to the World!

Freedom for all as long as we follow government guidelines!

But really, did you ever trust government? Surely not. No thinking person is ever so gullible as to believe in politicians; we know their all-too-common personality profile only too well. Within a brittle blustering exterior hide, immature little souls feeling unloved and inadequate, their charming feigned mature public face often covering a more power-seeking cum narcissistic countenance, a defence of their inner fear of shame fuelling an acting out of compensatory grandiosity. Buried deep within, alongside fears their store of authenticity and a scare of being found out – for they

become their role. Born actors! Boris Johnson, please stand up and take a bow as a shining example. Stunning indeed you are, Boris! Janus personified! Emotional ignorance combined with arrogance, an empathy bypass and a huge ego will seemingly get you a long way in politics.

To be fair, not all politicians fit this picture; Tony Wedgwood Benn, Ghandi, Jan Smuts and Nelson Mandela come to mind – more driven by inner philosophy than party politics. But these are the few, who ooze authenticity more than rampant self-interest and show-biz! These, the virtuous ones, could still be pompous pricks; but because they appeared to be saying and doing right and moral things, we forgive them. Nevertheless, as exceptions to the political rule, and, as politics naturally shakes hands with the news and intelligence services, we have no reason to feign surprise at being deceived. The reality of ‘Deep State, after all, is just another thing we and others have welcomed by choosing to ignore.

Politics aside, the shit-storm of Covid appears again as a carefully correlated, planned and news-managed event. And thankfully we are far from the only ones saying it; indeed, we shall hear it again soon enough from all too many horses’ mouths – the inventors of the mRNA vaccine, the Pizer boffins themselves.

Now to re-balance the books, some positive press action. News attention has at last been directed towards Dr Peter Daszak of EcoHealth Alliance, who said:

We need to increase public understanding of the need for Medical Countermeasures (MCM) such as a pan-influenza or pan-coronavirus vaccine. [During an infectious disease crisis] a key driver is the media, and the economics follow the hype. We need to use that hype to our advantage to get to the real issues. Investors will respond if they see profit at the end of the process.

The workshop from which this quotation originated addressed Rapid Medical Counter Measure Response to Infectious Diseases, and was co-convened by the National Academies of Sciences in 2015 – who proudly minuted this very quotation for public record! A big mouthful of an organisation with its figure-head verbalising an envisaged sham-demic some years before Covid! This self-same Peter Daszak is president of EcoHealth Alliance, a non-profit organisation who organised a five-year research programme funded by the US National Institutes of Health to study bat corona-viruses and the potential spill-over risk to humans. He was particularly aggressive in promoting the zoonotic spill-over hypothesis and attacking the laboratory-leak possibility as ‘a conspiracy theory’. It wouldn’t surprise us if he abetted the release himself! Come now, Peter, you are last to speak of conspiracy theory – pull the other leg, it has bells on! Did you not work on weaponising Covid in an earlier career? (Covid Revealed, 2021). Yes, indeed he did!

But hope appears again on the horizon as another hero rides to our aid, The Washington Post, the crusaders of Watergate, who are in hot pursuit on Dr Peter Daszak’s trail. The editorial team has called upon Congress to hold him to account for a report they commissioned into the origins of Covid just after the supposed Wuhan outbreak (2018–9) to explain why the said report was only submitted in August 2021 – two years late? – and thus conveniently avoiding the period in which we had our most intense debate about the pandemic and its virus origins! No reason was forthcoming even when *The Washington Post* followed up their concerns at source – so they are now hell-bent on taking it further (Washington Post, 2021)! Go for it, boys, we’re right behind you!

The report in question describes such contentious and dubious experiments as testing the infectivity of genetically manipulated viruses on mice – with cells resembling those of the human respiratory system! It even outlines manipulations made to render such viruses more lethal. Remember, lung complications are legion in the human form of Covid. How does this relate to the remit and purpose of the funded report – the origins of Covid? What’s going on here? Nothing more than the usual unsavoury dynamics of the righteous ones whom our silence empowers in high office and politics. We have to stand up and be counted for our rights and liberties – they will not be given to us by default!

But do not despair. We have no doubt that a scenario akin to Watergate is currently unfolding with an even more shocking outcome.

So much more about Covid doesn't add up. Some don't get Covid though exposed to the infection, some are Sars Cov-2 positive without ill-effects, some even have all of the symptoms associated with Covid-19 and still have no fragments of the causative agent in their body (Covid Revealed, 2021). No wonder many believe Covid-19 may be a story, a constructed narrative rather than a fact. Something we've been conditioned to believe in? After all, no one's raided tissue banks prior to 2019 to prove whether it's been with us all along – before we labelled it a new disease, let alone a pandemic. Makes you wonder why, not doesn't it?

Be patient, dear reader, just wait; everything will in time come out in the wash!

Sadly, until the wider envelope of propaganda breaks, what should be headlined on TV and speculated about in the press can only appear in articles such as this one – in non-traditional news sources. But as we write there are some hopeful signs. NHS doctors and nurses are now publishing truthful accounts independently (Wilks, 2021). Interestingly, a somewhat late whistle blower, Dr Wilks refers to the Milgram experiment, where your 'average Joe' was seduced into harming others when instructed to do so by an authority figure in a white coat – an apt metaphor, don't you think, for all the medical jobsworths who conveniently forgot their Hippocratic oath. How come medics were so easily persuaded? Then again, aren't medications and vaccines the very life-blood of allopathic doctors, their badge of office, their primary intervention and the object of their professional faith, with Big Pharma their major sponsors? How many drugs company-sponsored meals and lectures happen daily in hospitals and clinics? We've worked in the same, and suffered far too many to shake a stick at!

What would, or could, medics do without pharmaceuticals? Remember, 'We have a medical industry that has a pecuniary interest in doing things TO us, not FOR us. Subtle difference, hey?' (George Bernard Shaw, 1856–1950). Never a truer word! It has long been known that much of medicine is dedicated to rectifying previous medical interventions (Illich, 1976) inclusive of surgery and drug induced side-effects. We the authors gladly lost our faith in allopathic medicine long ago.

By now you can appreciate something of the field conditions and background scenery from whence the Covid Wars arose, plus the commercial and governmental pressures that ferment its putrid stream, the players central stage and ourselves as audience allowing the afore-mentioned entertainment to unfold – until there came a time when we were drawn by our compliance into playing an unwilling part of this pre-ordained drama especially written for us. Are you still an audience, or have you become an on-stage player? In truth, you are an active player, like it or not – be it by your consent or by default. Speak up now, come on stage and fill out an authentic role. The more Humanistic souls on board, the merrier and for the better.

Act 5: Why Do We Keep Knocking on Heaven's Door?

The only real prison is fear, and the only real freedom is freedom from fear.

What would a good story be without a tinge of fear? A hint of violence? With germ-warfare informed rushed vaccines bursting at the seams with rampant side-effects, a zombified mass hypnotised into compliance within their own downfall, with government and health services looking the other way – we have fear aplenty. We just have to be disciplined and supported enough not to slide into reactive depression or paranoia, or worse still, live life as a hapless melodrama where we keep repeating the same mistakes and letting the bastards keep getting away with it ad infinitum!

Having enjoyed vaccine-induced blood and respiratory problems earlier, queue-up now, folks, for your very own tailor-made cancers, TB and AIDS (Burkhardt, 2021)!

Some while ago a suspicion of HIV being induced by Covid vaccinations surfaced in Australia, at the beginning of 2020 (BBC News, 2020), though it was written off as a false positive and conveniently forgotten (see also Ives, 2020). Around the same year, articles appeared in *The Lancet* warning of the same (Buchbinder et al., 2020) and Pharmaceutical Technology (2021), which cited the withdrawal of South Africa from use of the Sputnik V Covid-19 vaccine due to HIV concerns. More recently, immunity suppression has again returned to haunt us, when journalist Dr Naomi Wolf, from her reading of the United Kingdom's Vaccine Surveillance Report (Government UK, 2021), claimed those 'fully vaccinated' for the Wuhan coronavirus (Covid-19) were losing on average 5 per cent of their immunity function per week! Believe this and many of us will have to cancel our summer holiday plans this year! Hopefully she was as confused as we were by the statistics upon the UK site (Government UK, 2021) and pray her calculations are untenable.

This said, on the more sobering side, many more sedate medical experts say we will likely see deaths from cardio-vascular complications within three years, and deaths due to immunity deterioration and cancer within ten. All this is very concerning, and we both wanted to disbelieve it on first reading. But then we remembered the research of Dr Ryan Cole, who reports that vaccines are de-stabilising the immune system by diminishing production of the KillerSD8 Type T cells which fight cancers – because of which he believes cancers have grown in the past six months, and will hence grow exponentially (Romania Info, 2021).

Another eminent virologist focusing on immunity recently broadcast that vaccinations are knocking out natural immunity and replacing it with the gene-based one we're being injected with. He warns that devoid of our God-given natural immunity, immunity exhaustion will set in and we'll need 'vaccinations for life', if we are to ward off any future infections (Marcu, 2021). Vaccination for life to counter our vaccination-ruined in-born immunity is now an ever-repeating theme from the lips of far too many world authorities. The inevitability of anti-body immune enhancement (ADE) due to vaccination, is, similarly, being echoed by the French Nobel Prize winner for medicine, (the now late) virologist Luc Montagnier (Aasish, 2021), along with Arne Burkhardt (2021), whose studies of post-mortem post-vaccination deaths confirm the progression of immunity suppression opening the door for multiple-organ failure from a multitude of attacking agencies.

Last but not least, it is claimed by some that recently released official German Government data suggest that the fully vaccinated will develop AIDS by the end of January 2022 (Exposé, 2022). Put all this together and acquired immunodeficiency syndrome, AIDS, repeatedly rears its ugly head. One can but wonder whether it was Big Pharma's intention all along to turn us into drug addicts and cause vaccine dependence? Be on guard, gentle reader; ever more vaccinations will be found to eradicate variants, side-effects of vaccination and immune suppression: go on buying the hype, and it will all become a never-ending story. It's in our very own hands.

Although much knowledge is at core interpretation, belief and supposition, too much hard evidence is surfacing to be so easily and readily ignored. Time, as always, will tell the full story. Being an inventive species, surely we can expect solutions? Indeed, alternative remedies to limit the complications of post-vaccination are already in circulation on the web, and we have personal experience of the same from tried-and-tested conventional medical and energetic alternative approaches. So don't seduce yourself just yet into a fit of total despair.

With so much doubt with AIDS in the air, and in the midst of a robust debate in swing against vaccination, still, the crazy notion of vaccinating children goes on! Even though Pfizer themselves, acknowledging in their internal meetings the high rate of heart attacks in children post-vaccination, saw fit to modify the ingredients of their child vaccines (Exposé, 2021a). But this is *hush hush*, so don't tell anybody.

Seriously – must we vaccinate children? The answer is a resounding, 'No!'.

Thousands of physicians and medical scientists have updated The Rome COVID Declaration with overwhelming evidence confirming the fallacy of vaccinating children. Gleaned from 20 months of exhaustive research, which included millions of patients and hundreds of worldwide clinical trials, they state categorically that *healthy children and COVID recovered people should be excluded from vaccine mandates and social restrictions* (GCS, 2021). Some 91 studies are cited in this thoroughly researched international project, which also notes the success of alternatives like natural immunity and conventional treatments like Ivermectin. But who's really bothering to listen when it fails to be reported on the national news, and we allow ourselves to believe that 'Nanny State knows best'. Far too few! But surrender to unreasonable control, and Nanny will never go away.

Many medics, off the record, know that COVID-19/SARS-Cov-2 is primarily blood and vascular disease that infects the lining of human blood vessels causing them to leak into the lungs, and that:

The correct treatment for severe COVID-19 related sepsis is non-invasive ventilation, steroids, and antioxidant for infusions (Durden, 2021). Ivermectin, as one such antioxidant, has a very good pedigree. For example: 'India went against the instructions of the WHO and mandated the prophylactic usage of Ivermectin. They have almost completely eradicated COVID-19. The Indian Bar Association of Mumbai has brought criminal charges against WHO Chief Scientist Dr Soumya Swaminathan for recommending against the use of Ivermectin.' (ibid.)

One study cites over 25 research studies in support of the effectiveness of early conventional treatment of Covid via such as Ivermectin (GCS, 2021). As expected, opposition to Ivermectin has not so much come from medico-scientific circles as from pharmaceutical and political ones. Unlike India, which acknowledged the Ivermectin route, Romanian politicians, similarly to the European States, chased EU cash incentives, purchasing vaccination doses far and above the population needs.

When even Michael Yeadon, former Pfizer Vice President and their Chief Scientist, has publicly pleaded with us not to take the vaccine (Yeadon, 2021) – let alone our children – how much more convincing do we need? Here we hear it personally from the originators, a plea for us to kill off their once-treasured progeny. Yet even this beseech falls on deaf ears – as does the message of another Pfizer boss, Dr Albert Bouria, who has recently yet again confirmed that we will need vaccinations for life (Kirby & Picover, 2021). Do we really want our children to be vaccine dependent? Again, it is not at all logical to ignore potent messages from Pfizer big-wigs such as these – that is, unless our deafness is more rooted in avoidance than sense, sanity or reason! Have we really allowed ourselves to be teased into a state of cognitive dissonance where we have ceased to trust our own brain and senses, let alone our intuition?

We draw your attention back to the opening brainwashing quotation of this article that indicates subjects, after as little as two months' indoctrination' reaching a position where 'no amount of clear messages to the contrary, will change their minds!' (after ISDPA, 2021). And we've already had two full years of it!

So, who upholds the true faith – the vaxxers or the anti-vaxxers? They can't both have God on their side, surely? We admire open minds, but how mind-blowingly hard someone must work to ignore Bouria's and Yeadon's combined messages and the evidence cited here, so as to continue to contemplate playing Russian roulette with their children's lives.

Must we really condemn ourselves to a potential re-living of a 'slaughter of the lambs'? – especially when official data published by the Office for National Statistics (ONS) proves that deaths among children have increased 44 per cent higher to the five-year-average since being offered the Pfizer mRNA Covid-19 vaccine (Exposé, 2021b). To rub the point home, we will leave you with a headline distilled from the vaccination research of Tony Rogers (Rogers, 2021), summarised by Steve Kirsch that sums up the abject stupidity of child vaccination: 'We will kill 117 kids to save one child from dying from COVID in the 5 to 11 age range' (Kirsch, 2021).

May God forgive the blind and ill-informed ones in our midst, for it's doubtful our children will.

The Epilogue: A Personal Postscript

In our first jottings, bewildered at what was happening around us, far from the territory of conspiracy theorists and believing the best, we thought fatal errors were being made in the government's knee-jerk response to a newly emerging virus (Barber, 2020; Barber & Barber, 2020). We believed that when the research was known, all would be well. But it was suppressed, and never got out! And what little did get out wasn't believed because it wasn't on telly or in the daily papers. We still believed in the power of facts at that time – a fatal error, we now realise. Our original stance of 'this is all an accidental error' gradually changed, bringing us alongside so-called 'conspiracy theorists', those who we now believe were correct to suggest that:

- Vaccines are doing more harm than good by spike protein transmission and by the creation of ever more variants, vaccine dependency and lethal auto-immune conditions;
- Various successful non-vaccine interventions have been, and are currently still being suppressed by governments and Big Pharma in favour of vaccines and expensive patented drugs;
- There is a vast criminal conspiracy in bud as evidenced in the patent record directly linking Anthony Fauci and Moderna, amongst others, to the Wuhan Institute of Virology;
- Current treatment protocols (ventilation) and counter-measures (masks and lockdown) are inadequate to slow the evolutionary spread of Corona virus and variants;
- The authorities continue to deny the usefulness of natural immunity despite the researched fact that it confers protection against the pathogen and variants born of vaccination;
- Death-rates and damage due to the side-effects of Covid vaccinations, especially in the multi-vaccinated, are being hidden and erased from the public record;
- That death rates from Covid were, and still are, being exaggerated by a catch-all approach to statistical collection and analysis;
- Independent researchers have discovered graphene oxide and other mysterious nano-particles inside vaccines and on face masks that are not supposed to be present, whose very existence is consistently denied by manufacturers, even when confronted with evidence to the contrary.

We await further evidence before subscribing to other theories we list below, although we have seen an unconfirmed evidential base for some of them, such as of the possibility of a brain–computer interface and the role of nano-particles – both linked to the presence of graphene oxide since proven. To give some idea of how the unaccepted progresses towards acceptability, it will be instructive to describe our own journey with graphene oxide.

Some twelve months ago, many of our Romanian colleagues informed us informally that graphene oxide was being discovered in vax vials, on masks, in hand sanitisers and such as Covid testing nasal swabs, but without supporting evidence we ignored it. Subsequently we stumbled upon evidence (White, 2021), so we gradually allowed its tentative movement towards the above accepted list, but not before a period of soul searching, during which we discovered that graphene oxide (GO) is used by bio-technology and medicine for drug delivery and cellular imaging, that it was characterised by nano-scale size, high surface area and electrical charge. We also discovered studies showing that it stimulates severe blood clotting via magnetising red blood cells, causing them to clump when administered internally, and that lung damage occurs (in a similar way to asbestos) when it is introduced externally (Yang et al., 2020). At this stage, we asked ourselves what on earth is the purpose of this highly conductive material? We dared not think of the answer with so much indigestible rumours of population culling, 'brain–computer interface (neural lace) technology' and 'mind control' littering the web, so we felt more comfortable shelving it under a file of 'red herring'. But since reading a well-researched paper linking graphene oxide to the same (Mik, 2021), we now believe that graphene oxide is certainly in vaccinations, but we remain unsure as to the

reason it was introduced covertly – to facilitate vaccine efficiency, to speed up death, pave the way for robotising the human race, or something other? Because of this need to keep an open mind, our disbelief is starting to wobble towards entertaining more outlandish theories, which we have moved from our ‘red herring’ to our ‘pending’ file. This said, the propositions below we are still finding hard to swallow, let alone digest:

- As we write, the UK is about to experience a huge wave of deaths in Winter 2021 and Spring 2022 among the elderly and vulnerable comparable to April 2020; but Covid-19 as then will not be to blame, but the use of Midazolam and enforced end-of-life protocols to boost Covid/Omicron deaths rates (Exposé, 2021:3).
- Although we now accept that graphene oxide has been identified within vaccinations, we await more evidence about Covid-19 vaccine researchers being directly linked to scientists involved in brain–computer interface (‘neural lace’) tech, one of whom it is rumoured was indicted for taking grant money from China with a view to exploring mind control.
- The entire pandemic is being used as an excuse for the political and economic transformation of Western society – the global reset and globalist thesis (Durden, 2021).
- That 5G is linked to the mind-controlling effects involved in the mind–computer interface and is designed to switch on and facilitate future systems of governmental mind control, of which vaccinations pay a part.
- The Rockefeller Foundation in 2010 published the ‘Scenario for the future’, in which they describe a coming global pandemic, that should result in the implementation of the authoritarian control over the people, which will soon intensify after the pandemic.
- Dr Carrie Madej, who studied DNA and vaccines for decades, says the real plan is to use the COVID-19 vaccine to start the process of trans-humanism: reprogramming human DNA (Madej, 2021).
- The CIA officer Dr John Coleman who has studied secret societies maintains that the overall goal is to depopulate the earth by means of organised pandemics of fatal rapid-acting diseases (Coleman, 1992).
- Extra-terrestrial agencies are conspiring with governments and powerful others to wipe out the human race (HRR, 2022).
- The Covid virus was formed by nature, vaccines were created by a beneficent big pharma whose only motive was to promote health and serve mankind, and as the government rightly says, any vaccine side-effects are minor and transient, and will soon pass.

To our minds, it is the last on the above list (not the next to last) that is the most far-fetched of all!

Sifting emerging fact from blatant fiction is a full-time job in these unbelievable times. For example, the supposition heading this list – claiming that in April 2020, the UK government subjected the in-care elderly and vulnerable to the drug Midazolam, along with end-of-life protocols to boost up numbers of Covid deaths, coupled with the suggestion that a similar exercise is planned to exaggerate Covid/Omicron deaths in Winter 2021 and Spring 2022 – though begging to be dismissed on first sight, has disturbing ongoing rumblings! – especially when we discovered that on 12th November 2021, the UK Government’s Department of Health and Social Care (DHSC) had published a tender inviting suppliers to bid for ‘End of Life Care Medicines for Covid-19 Preparedness’, in which they state that the DHSC wish to ‘top up the stockpile holdings of Midazolam and Noradrenaline medicines in preparation for further waves of Covid-19 in Winter 2021/Spring 2022’ (Government UK, 2021).

Now it all turns kind of interesting, for we have on record, from government, a prophecy of a new wave of Covid infection and a hint of drug-inspired deaths in Winter and Spring. Remember, we unearthed earlier a Whitehall paper recommending ‘end of life pathways’ for the over 70s (*Telegraph*, 2021), so one can but speculate, did it really have happen and, if so, could it happen again? Add to this preposition that stocks of Midazolam meant to last two years, bought in April 2020, were used up by October 2020 – some six rather than twenty-four months later (Exposé, 2021c), and doubts are doubly seeded. The plot also thickened for us when a readily available reference addressing drug tenders freely accessed via web (Government UK, 2021) in early December 2021 was denied us a few days later; neither did they let us even sign in nor browse their contracts page. One has to ask, had they black-balled us? Had they just begun to hide the evidence and we’ve caught them red-handed doing so? When such intrigue as this happens, you’ve got to wonder, haven’t you?

So, with so much at shift, where do you, O noble reader, stand in these endarkened days? Which of the scenarios we have laid before you are you tempted to entertain? Come on, change faith, come out from the dark side and over to the light. Shake hands with uncertainty and research mindedness. We have to entertain craziness and hold it in a pending file when so much which was unbelievable 24 months ago is now coming true! Flying or grazing, dear reader – flying with the Gods, or grazing with the herd?

Sadly, we have been a little too accurate for our own comfort in the summations of earlier articles. In our first we raised questions regards the inflation of Covid into a pandemic, the falsification of statistics and news, the potential loss of civil rights and of trust in government, together with the dangers of rushed through unproven vaccinations (Barber, 2020). In our second paper we drew attention to the statistical inflation of Covid deaths, the abuses of the WHO, the uselessness and futility of masks and PCR testing and lock-down, the actual erosion of personal freedoms and individual rights and real live reported dangers of vaccination (Barber & Barber, 2020) – all of which became facts. In our last scriblings, we reviewed the suppression of alternative cures, the deception around vaccination side-effects and ensuing deaths, the continued creation of variants, pharmaceutical deception and cash incentives to push vaccination, plus the damaging effects of spike proteins and the promise of auto-immune responses ahead (Barber & Barber, 2021) – everything we are living through and writing about now. Hopefully the spectres we now conjure up of mass deaths from vaccination-induced AIDS and government-sanctioned culling will for ever remain erroneous presumptions rather than materialising into fact. Regretfully, we are not all that optimistic short term, for these are indeed horrific times, however we slice them up, but long term, we believe that will be a very different story.

Such is the damage to our trust that writing for the 'Humanistic free press' has done to us in the current social climate that we believe it merits a Government Health Warning! A collection box will also be passed around shortly [...] There is an ulterior motive to the cultivation of humour in this article, no matter how irksome you may have found it: it is proven to act as a tonic for the immune system (Mayo Clinic, 2021); and likewise, faith in things divine helps immunity – inclusive of the belief in 'a divine teacher within us all'! Fear and anger, conversely, mess with your immunity big time.

In these fear-enforcing times, humour becomes 'an act of rebellion' as well as 'health'.

The sleazy games of modern times may have bruised our trust in fellow man, but we won't let them take away our humour – although we must admit that it's gained a tinge of black to it of late. We've also, in brief moments, become a little too despairing and cynical for our own comfort – so as to entertain too closely Hood's immortal words:

I wish I loved the human race
I wish I loved its silly face
I wish I loved the way it walks
I wish I loved the way it talks
And when I'm introduced to one
Wish I could say what jolly fun!

Thomas Hood 1799 –1845

Being human, we can fall all too easily into compassion fatigue where we give up and lose hope! At times like these, our belief in Humanism and its reminder of all that's best in humankind returns to save us. Yet, how does one square Humanism with cynicism? Anyway, for better or worse we believe we are now in a recovery stage!

In this writing we are caused to contemplate the bigger picture, namely, how much responsibility by default we have all given away to 'Big Pharma', 'Big Brother' (in the shape of *Deep State*) and 'Big Commerce' (inclusive of the entertainment and news services) who we've let shape our lives, reality and society. Essentially, to do our thinking

for us. These unelected bodies often have greater power behind the scenes than the elected puppets strutting in front of us - so there they stay. And as long as we get what we want (workable individual freedom) and they get what they want (workable mass control) the whole charade cum perverse protection-racket goes on. But the ego is hollow and greed and power are insatiable political gods. Hopefully undercover forces have shot their bolt too soon and we can now, awake, know them for whom they are and give better shape to the reality we choose for ourselves. Awareness coupled with humanism raises us from the status of cash cows to compassionate social players who choose to uphold human worth and dignity. Humanism furthers these values.

So, to sum up the plot so far.

We think it's more than proven that a medico-pharma commercial and government-abetted health scam is underway with repeated mass vaccination, vaccine dependence and monetary rewards as targeted outcomes. We also believe that a behavioural experiment is at play with social psychology and mass-media manipulation underpinning it. The evidence, for us, with life preservation being ignored, also strongly suggests that population control cannot wholly be ruled out. Other sub-plots and agendas are no doubt piggy-backing on these. Many governments will deservedly fall. Will those behind these movements get away with it? No! Too many are beginning to smell a rat and to locate who are the rats in their midst. Never has evil been so visible. Short term, there will be hardships – especially for the vaccinated; but in the long term we feel that solutions will be found and we'll see renewal and liberation. We are therefore placing our faith in a renaissance of decency.

So, what sort of drama has been illuminated by this play? Was it comedy, tragedy, tragic-comedy or melodrama? We guess tragic-comedy. shading into melodrama rings a bell, for we didn't know whether to laugh or cry at many points of our story; but unlike most tragi-comedy it doesn't as yet have a happy ending, and unlike most melodrama it had complex multi-layered themes rather than a simple noble one. In political terms, taken as a whole, sadly, it stands nearer a new category entirely – a tragi-farce, with death by misadventure via Covid jab flavouring one end of the continuum, and the 'high nonsense' of vaccinating children at the other. Unfortunately, we can't drive home to our beds following this drama, for it is ongoing, and like it or not we are all bit players locked on stage with the curtain refusing to go down!

Our greatest threat comes not from evil ones but stupid ones. Evil can always be exposed and taken down by enough people of good heart. But against stupidity we are defenceless, because protests, arguments and even force is ineffective in changing such minds. (Sadly, highly intelligent minds are not immune to stupidity.)
