# United Nations declares intent to lock us down

The UN General Assembly president has approved the non-binding UN declaration on Pandemic Prevention, Preparedness and Response (PPPR) – without a full assembly vote, despite eleven nations objecting. The declaration seeks to create a global pandemic authority with power to enforce lockdowns, universal vaccination and censorship of ‘misinformation’.

Frank Gaffney, president of the Center for Security Policy: it’s ‘very worrying’ that the UN and WHO ‘will further encourage... the kind of standing capability or authority... to essentially dictate what constitutes emergencies.... It’s going to come at the expense of the sovereignty of the various nations that will subsequently be told that they have an emergency and told what they have to do about it.... This is unprecedented.’

Dr David Bell, Brownstone Institute: the text is ‘clearly contradictory, sometimes fallacious, and often quite meaningless’, and intended to centralise the WHO’s power.

The final text of the PPPR political declaration, dated 1<sup>st</sup> September, calls for:

- **Universal vaccination**
- **Making ‘temporary’ covid-19 powers permanent**
- **Increased surveillance & digital health documents, like vaccine passports**
- **Potential social media censorship**

A letter co-signed by eleven countries, including Bolivia, Iran, the Russian Federation and Zimbabwe, said ‘legitimate concerns were being ignored’: ‘This is no way to handle multilateral and intergovernmental negotiations on issues of great relevance for the international community’, adding that ‘no consensus has been reached on any of these processes’.

Dr Bell added, ‘People and corporations who sponsor much of the WHO’s health emergency work... did very well from the policies they advocated so strongly for’.
